## EXPLANATORY NOTE

SCYNEXIS, Inc. (the “**Registrant**”) is filing this Registration Statement on Form S-8 for the purpose of registering an aggregate of 789,488 additional shares of its Common Stock, issuable to eligible persons under the SCYNEXIS, Inc. 2014 Equity Incentive Plan and the SCYNEXIS, Inc. 2014 Employee Stock Purchase Plan (collectively, the “**Plans**”), which Common Stock is in addition to the shares of Common Stock previously registered on the following Form S-8s (collectively, the “**Prior Form S-8s**”) pursuant to the Plans:
